PREAMBLE

- 1. The Mumbai Metropolitan Regional Plan (1970-91) came into effect from August 16, 1973. This plan indicated the policy to be followed for location of industries in the region and provided for review of this policy. The Industrial Location Policy was first laid down in a Circular Memorandum, Industries, Energy and Labour Department No. IDM 1074/933982/Planning, dated 26th December, 1974. During implementation, as and when difficulties arose or when change in policy was necessitated, it was revised from time to time.
- 2. The Industrial Location Policy has now been in force for about 24 years. In the wake of the liberalized policy announced by the Government of India, the State Government has also formulated its Industrial Policy in 1993 and accordingly a comprehensive Industrial Location Policy for Mumbai Metropolitan Region came

into force vide Government Resolution No. ILE 1092/3410/IND 2 dated 4th May, 1993. The basic approach of this policy has been to address the issues of declining employment in Mumbai and its suburbs, need of modernisation, diversification and expansion of existing industries without sacrificing—the objectives of decongestion and ensuring pollution free environment.

- 3. Subsequently the State Government enumerated its Industry, Trade and Commerce Policy, in 1995. Accordingly and having regard to the implementation of the Industrial Location Policy over the past years, certain modifications were made in it.
- 3.1 Expansion, modernization, diversification or change of manufacturing process has been allowed for industries in Schedule II, in Zone I, provided the overall source pollution decreases and does not require additional power and additional built-up area for manufacturing purpose, *vide* Government Resolution, Industries, Energy and Labour Department, No. ILP-1095/(4410)/IND-2, dated 25th May, 1998.
- 3.2 In the recent meeting of the Committee of Secretaries for Industrial Development (COSID), it was decided to include certain items in Schedule I which do not cause any pollution. These items now appear at Sr. No.11 to 14 in the Schedule I, annexed hereto.
- 3.3 Certain sections of Industries which were not listed in Schedule I and II, pointed out that especially small scale industries (SSI) have been facing hardships. This sector felt that, mostly engineering units outside Greater Mumbai Municipal Corporation limits, especially in Thane Municipal Corporation area and Mira-Bhayander Municipal area, be allowed to operate provided they do not pose any pollution problems. Having regard to all the above developments, the Government has, after careful consideration, decided to further revise the Industrial Location Policy, as indicated below.

RESOLUTION

- 4. This policy is applicable to all industries in Mumbai Metropolitan Region (MMR) excluding Cotton Textile Industries, go-downs, service industries and service industrial estates. Wherever necessary, the locational clearance under this policy is subject to approvals from Ministry of Environment and Forest, Government of India and the Environment Department of the State Government under the Environment Protection Act, 1986; approval from the Maharashtra Pollution Control Board and the strict enforcement of pollution control measures specified by the Maharashtra Pollution Control Board. The locational clearance is also subject to the provisions of the Regional plan for Mumbai Metropolitan Region, the development plan and development control regulations applicable to the land to which industrial proposal relates.
- 5. Zoning and Classification of Industries.
 - 5.1. For the purpose of the revised industrial location policy, the Mumbai Metropolitan Region shall be divided into the following zones:-
 - Zone I:- consisting of Greater Mumbai and areas of Thane Municipal Corporation and Mira-Bhayander Municipal Council.
 - Zone II:- consisting areas of Kalyan and Navi Mumbai Municipal corporations; Ulhasnagar, Ambernath, Kulgaon-Badlapur Municipal councils; Bhivandi and Uran sub-regions as described in Schedule III and Vasai-Virar sub-region as per Notification No. TPS 1287/2753/CR-228-81/UD-12, dated 14th May, 1990. (Schedule IV)
 - Zone III:- consisting of the remaining areas of the Mumbai Metropolitan Region, excluding the areas covered under Zones I and II above.
 - 5.2. Industry shall be classified into four categories, viz.:-
 - (a) non-polluting, high-tech or high value added units as listed in Schedule I;
 - (b) engineering units as listed in Schedule I-A
 - (c) highly polluting, hazardous or obnoxious units as listed in Schedule II;
 - (d) Residuary industries: The Industries not covered in Schedule I, IA and II
 - 5.3. For all categories of industry in all three zones, built up area and / or additional connected load shall be permitted for the following purposes:-

- (a) For goods manufacturing practices as certified by FDA required for compliance of Drugs and Cosmetics Act, 1940
- (b) For Research and Development, as certified by Department of Science and Technology, provided the activity does not add to pollution and is an integral part of the unit. For independent R & D, no NOC would be necessary.
- (c) For anti-pollution equipment certified by the Maharashtra Pollution Control Board.
- 6. In supersession of all the previous orders, the industrial location policy for Mumbai Metropolitan Region, with reference to each of the three zones shall be as stated hereinafter. However, existing Industrial Estates without final NOC (of the Directorate of Industries), will be allowed to apply for final NOCs to the Directorate. They will continue to be governed by the provisions of the Government Resolution dated 3rd February,1984.
- 7. The eleven (11) categories of industries mentioned in Schedule IA will be permitted in Zone I of Mumbai Metropolitan area excluding Greater Mumbai Municipal Corporation area i.e. these industries will be permitted in the area within Thane Municipal Corporation limits and also within Mira-Bhayander Municipal Council limits subject to the following conditions:
 - a) These should be existing or industries proposed to be located within the Thane Municipal Corporation area and Mira-Bhayander Municipal Council area of Zone I of Mumbai Metropolitan Region.
 - b) These industries should be non-hazardous and the industrial process does not cause any chemical, air and water pollution from these units. For this purpose such industries will have to obtain proper certificate from Maharashtra Pollution Control Board and the concerned competent authority.
 - c) Such industrial units should be in the MIDC areas or in co-operative industrial estates and industrial estates approved by the Directorate of Industries.
 - d) If necessary, the concerned industrial unit will initially install proper system for pollution control.
 - e) The industries in the above category viz; Schedule IA which are in existence on the date of this resolution but established after 4th May, 1993, will be

regularized after payment of penalty. The amount of penalty will be decided by the Directorate of Industries and by MIDC for units in MIDC Area.

- 8. Restrictions will apply as set out in the appended Table for the three zones.
- 9. A committee will be constituted comprising Secretary (Industries), Principal Secretary (Urban Development), Secretary (Environment), Metropolitan Commissioner (MMRDA), Municipal Commissioner (BMC) and Development Commissioner (Industries) for interpretation of any point arising from this Resolution.

- 3. Proposed industrial estate construction on an open plot
- (a) will be allowed for housing Schedule I industries only.

- b) will be allowed for schedule IA Industries in Thane Municipal Corporation Area and Mira-Bhayander Municipal Council Area subject to condition in Para 7 of this GR.
- (b) In MIDC areas, construction will be allowed even for housing Schedule II industry.
- (c) will not be allowed for housing other than (a) and (b) above.
- Expansion of approved industrial estates
 (having final NOC)/division of gala or structure

Will be allowed to house only Schedule I industries and Schedule IA Industries in Thane Municipal Corporation Area and Mira-Bhayander Municipal Council Area subject to condition in Para 7 of this GR.

- (a) will be allowed for housing other than Schedul II industry.
- (b) In MIDC areas, expansion/division will be allowed even for housing Schedule II industry.

No NOC will be needed for units in Zone III

- 3. If the allottee has not taken the B.C.C. within 3 years from the date of possession of the plot, then the copy of the time limit extension granted by Regional Office, MIDC, is required.
- 4. If the allottee has not started production within one year from the date of possession of the shed, then copy of the time limit extension granted by Regional Office, MIDC, is required.
- 5. For expansion NOC (i.e. expansion of the existing unit) the following additional documents will be required.(a) Copy of Previous NOC(b) Copy of SSI/IEM/Industrial Licence
